- 3. ALL APPLICATIONS MUST HAVE AT LEAST ONE (1) RECCENDATION LETTER.**
- 4. NOMINATIONS MUST BE SUBMITTED BY SOMEONE OTHER THAN THE NOMINEE.**
- 5. ALL APPLICATIONS SHOULD BE SUBMITTED IN A LEGIBLE MANNER. THE OFFICIAL 2017 FORM WILL BE THE ONLY ONE ACCEPTED.**
