TOURNAMENT RULES

1. Tournament will consist of singles event open to **all Gulf Coast sanctioned bowlers only**.
2. Bowler's can only bowl in one division.
3. Any errors in scoring must be reported to the Tournament Director prior to Step Ladder Finals.
4. **Bowlers arriving late must start their game in the frame that is being bowled and will receive a zero for frames missed. No refunds on, or after, the day of the tournament.**
5. The tournament director will rule on anything not covered by these rules or USBC tournament rules. All decisions of the tournament director are final unless an appeal is made in accordance with USBC Rule 329.
6. Bowlers must check in 30 minutes before scheduled time to bowl.
7. Total entry fee must be forwarded with entry form. Entries without fee will not be honored. Once entry is processed no refunds.
8. **AVERAGES** used will be **the HIGHEST GCUSBC CERTIFIED FINAL LEAGUE** average bowled previous year (2016-2017) including substitute averages of 21 games or more. **If a bowler does not have a previous year’s average**, HIGHEST 2017 summer league average consisting of minimum of 21 games must be used. Anyone not qualifying above must use HIGHEST current average of at least 21 games attained prior to time scheduled to bowl. All others will bowl scratch. USBC rules 319a-2 and 319e do NOT apply.
9. **IT SHALL BE EACH BOWLER’S RESPONSIBILITY TO VERIFY THE ACCURACY OF THEIR AVERAGE.**
